Kirkby Fleetham with Fencotes Parish Council

Minutes of meeting – 16^{6h} May 2019 following the Annual Parish Meeting.

Present: Mrs Booth, Mrs Herbert, Mrs Bradley, Mr Coop, Mr Jones, Cllr Wilkinson, Cllr Phillips and 3 residents.

- 1. Apologies: Mr Tubby
- 2. Councillors' Acceptance of Office, Declaration of Interest and Election Expenses.

Councillors completed the required documents.

3. Election of Chairperson

Cllr Herbert proposed Cllr Booth and Cllr Bradley seconded this. It was agreed unanimously.

4. Election of Vice Chairperson

Cllr Booth proposed Cllr Herbert and this was seconded by Cllr Bradley. This was agreed unanimously.

5. Minutes of the Parish Council Meeting held on Thursday 18th April 2019 were accepted and signed. It was noted that the Burial Authority Meeting had been moved to the June agenda. Acceptance was proposed by Cllr Herbert and seconded by Cllr Booth.

6. Matters for Report

Item 3 (ii) – The signpost at the end of Todd Lane has been reported to NYCC Highways for correction. Regarding the other signposts Cllr Wilkinson updated the council and also said she would highlight concern re the signpost opposite the former shop.

Item 9 – Allerton Park. The hub is circulating a notice for people to sign up to a visit. They are looking at a date in September for the visit.

Item 11 – Revised Bus Contracts – Councillors had written to North Yorkshire County Council about their concerns with the new service and the response had not been encouraging. Cllr Wilkinson informed the meeting that the contracts would be reviewed during the coming months and a detailed letter explaining the problems could be a way forward. Councillors agreed that this should be an item for the next agenda.

7. Draft Standing Orders

Cllr Booth explained the importance and use of Standing Orders to the new councillors and some of the salient points. She then informed the meeting that councillors had been up-dating our own Standing Orders, currently on the website, in line with recent advice and a draft copy of the new ones would be sent to each of them. It was agreed to place adoption of the new Standing Orders on the June agenda.

Cllr Booth expressed an interest in this proposal and left the room.

The remaining councillors discussed the proposal and agreed that, as this could not be viewed from the road and had previously been approved, the variations should again be recommended for approval.

This application was granted.

c) Solar Installations

A request had been received from Lightsource BP for a meeting with the Parish Council to discuss a potential development in the Parish. Councillors suggested that 7pm on June 20th would be appropriate and Cllr Booth offered to arrange this. The clerk was asked to contact HDC Planning to ascertain whether any information should have been sent to the Parish Council.

(10) Laptop for the Hub

Councillors discussed this proposal and there were a number of concerns around both the security of the item, data protection and unsupervised access to websites. Members of the public present were asked if they were aware of any interest within the parish for such a facility and it was agreed that this was not the case. Councillors decided not to pursue the matter further.

11) Appointment of a representative to the YLCA local meetings

Councillors considered the request from YLCA for the appointment of representatives but decided that, at the present time, they did not wish to appoint any.

Finally, the clerk was asked to write a letter of thanks to retiring parish councillors for their contributions to the welfare of the parish and support for the Parish Council.
